Court System Ordinance: Mayor Randy Banks presented the Court System Ordinance prepared by Atty. Jeff Rusbridge. Cheryl Sams made a motion to adopt the ordinance to amend the Code of Talking Rock to provide for the operation of a municipal court. James Bryant seconded the motion. All voted unanimously in favor.

Court System Contract: Mayor Banks stated attorney Jeff Rusbridge had not received the contract back from the county attorney yet for review. Cheryl Sams made a motion to table this item. James Bryant seconded the motion. All voted unanimously in favor.

## **New Business:**

2019 Budget Amendment Resolution: Mayor Randy Banks stated that there were some line items that went over the budget. The biggest one being FEMA. Cheryl Sams made a motion to accept the 2019 budget resolution. James seconded the motion. All voted unanimously in favor.

Randall Herrick Donation Letter: Mayor Randy Banks stated Mr. Herrick had asked for a letter as record of donation for \$4500 for tax purposes. He provided the material and labor for the council booth. Cheryl made a motion to send a letter to Mr. Herrick. James Bryant seconded the motion. All voted unanimously in favor.

Community Bank Loan Resolution: Mayor Randy Banks stated that Community Bank of Pickens County would approve a loan for the town for necessary improvements to the railroad sidetrack using the two CDs the town has for collateral. Cheryl Sams made a motion to approve to do a loan with Community Bank of Pickens County to make necessary repairs to the sidetrack and authorize the Mayor and Town Clerk to sign the loan documents as a resolution and use the CDs to secure the loan in the amount of \$30,000. Jeremiah Stone seconded the motion. All unanimously voted in favor.

## **Executive Session:**

Personnel: Mayor Randy Banks stated he would rather have all council members present before doing the executive session. Cheryl made a motion to remove the executive session from the agenda and at next week's work session have a called meeting and executive session at that time. James seconded the motion. All unanimously voted in favor.
